AN ORDINANCE

Control and Use of Alcoholic Beverages In the Town of Sunapee

THE TOWN OF SUNAPEE ORDAINS:

Section 1: It shall be unlawful to consume, attempt to consume, or possess any

container, with factory seal broken, having therein any alcoholic liquor or malt beverage in or on any property owned by the Town of

Sunapee.

Section 2: Alcoholic beverages and malt beverages shall include all distilled

liquors or rectified, spirits, vinous, fermented, brewed and malt liquors, any beverage by whatever name called, having an alcoholic content of not less than ½ percent of alcohol by volume and more than 6 percent alcohol by volume at 60 degrees Fahrenheit; and any beverage if which any part is an alcoholic liquor or malt beverage.

(RSA 175:1 VIII)

Section 3: The Board of Selectmen, upon application, may issue a permit to any

person, group or corporation for the consumption of alcoholic liquors or malt beverages within a prohibited area. Such terms and conditions Of permit will be set by the Board of Selectmen. They may charge

a reasonable fee for such permit.

Section 4 A first offenses shall be punishable by a \$100.00 fine. All subsequent

offenses shall be punishable by a \$250.00 fine.

Section 5 All fines shall be paid at the Sunapee Town Hall or the Sunapee Police

Department, Monday through Friday during normal business hours.
